Statistics Order (Population Census), 5768 – 2007

By the power vested in me by Section 6 of the Statistics Ordinance (New Version), $5732 - 1972^1$ (hereafter – 'the Ordinance'), and after consultation with the Statistician and the Council, I hereby order:

Definitions

1. In this Order –

"the census" – the 2008 Population Census;

"The Determinant Date" – midnight of Saturday evening, 27 December, 2008);

"Resident of the Country" -

- (1) Every person present in Israel on the Determinant Date, except for anyone staying in Israel for a period of less than one year and who is not a citizen of Israel or doesn't have an Immigrant Visa or an Immigrant Certificate or a Permit of Permanent Residency in Israel and except for anyone present in Israel by power of a diplomatic passport;
- (2) Anyone outside of Israel, and who on the Determinant Date fulfilled the following two conditions:
- (a) Was outside of Israel for a period of less than one year;
- (b) Until leaving Israel resided in it as an Israeli citizen, whether by an Immigrant Visa or an Immigrant Certificate, or by a Permit of Permanent Residency in Israel;

"Institution" – a hospital, a mental hospital, a senior residents' home, an orphanage, an educational institution, an absorption center, a boarding school, a camp, a monastery/convent, a prison, a hotel, a guest house, or any other residence or place in which people sleep, are sheltered, are hospitalized, stay or reside.

Census Period

2. The census shall be conducted during the period of 1 December, 2008 to 19 February, 2009.

Census Extent

3. The census shall cover the residents of the country on the Determinant Date.

Authority of the Statistician

- 4. For purposes of conducting the census the Statistician is authorized to $-\,$
 - (1) Divide the country into census regions and the regions into sub-regions;
 - (2) To appoint; either personally or by anyone else he empowers to do so, regional directors, deputies to regional directors, supervisors, coordinators, enumerators, messengers, and other workers;

(3) To determine the census arrangements in an announcement that shall be published in any fashion he sees fit.

Census Subjects 5. The subjects to be included in the census questionnaires shall be determined with the approval of the Statistician, and will be presented on the Central Bureau of Statistics website, at: http://www.cbs.gov.il.

Respondents to the Census **Questionnaires**

- 6. The following shall respond to the census questionnaires and provide, to the best of their knowledge, correct details regarding the persons specified as close to them:
 - (1) Anyone aged 15 years and over regarding themselves and members of their household, and persons sleeping in the same dwelling;
 - (2) Director of an institution regarding the people being educated, sheltered, hospitalized, sleeping, staying or residing in that institution.
